1. This contract shall become binding upon its receipt and acceptance by the home office, Murrells Inlet, SC. All orders are subject to prices in effect on date shipment.  
 2. All merchandise is shipped F.O.B. our warehouse. Discrepancies must be reported within 5 days after receipt of goods. Seller shall not be responsible for any loss or damage once shipment is delivered to carrier or agent thereof. Place all claims for damage, apparent or concealed, with carrier. Merchandise may NOT be returned without written authorization - unauthorized returns will not be accepted.  
 3. If seller incurs any expense in collection of payments or in enforcing the terms of this agreement, Buyer, and Buyer's agent(s), hereby agree(s) to submit to the jurisdiction of the courts of SC and that venue shall lie in Georgetown County, SC, USA. Buyer and its agent(s) further agree(s) to pay all such costs and expense including reasonable attorney's

fees, service charge of 1.5% per month until collected in full, court cost and incidental expenses. All past due balances will incur 1.5% SERVICE CHARGE PER MONTH ON THE ENTIRE BALANCE DUE until paid in full.  
 4. It is further agreed that receipt and retention by Buyer and / or Buyer's agents of the above noted goods for a period exceeding ten (10) days shall be deemed further acceptance and ratification of all terms herein expressed. Where Buyer is a closely held corporation, receipt and retention of above goods beyond said ten day period shall personally bind and obligate Buyer's agent and all stockholders of said corporation, jointly and severally, under the terms herein expressed.  
 UNLESS OTHERWISE NOTED, THE ABOVE TERMS AND CONDITIONS WILL APPLY TO ANY AND ALL FUTURE CONTRACTS FOR PURCHASE AND SALE OF MERCHANDISE.
